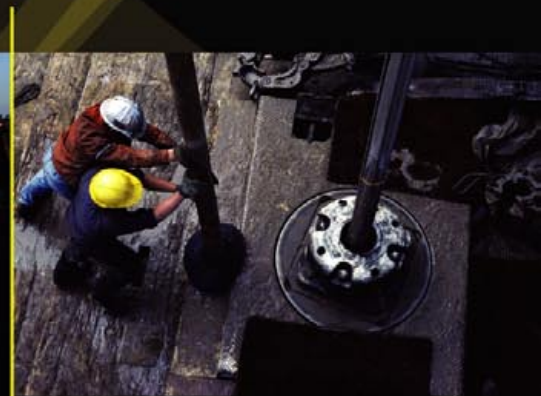




Modern Safety Management Course

Supervisors, Team Leaders, Direct Line Managers and Safety Officers and SHE Coordinators.

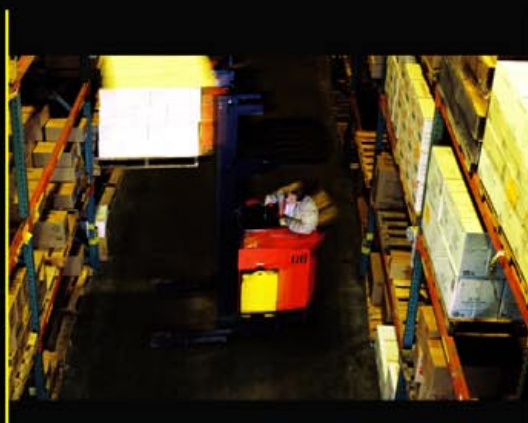
By Attending This Highly Interactive Course You will be able to:
